- A419 Missing Link: Due for completion Spring 2027
- CDC Housing Requirement: now 1,000 per year. Housing need does not take into account lack of resources in communities e.g Tetbury has no Senior High School.
- Bin Collections: Major issues/complaints; new longer rounds, inexperienced drivers, more frequent need to offload at tip, rounds not completed. Yet to be resolved.

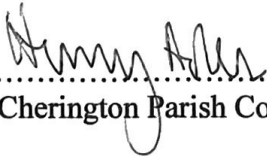
9 VILLAGE ISSUES
